QMed's observations and actions:

Literature searching and referencing skills are based on the domain of Information Sciences and need to be taught with a structured approach. This is lacking in the Indian medical curriculum. QMed Knowledge Foundation is working on this issue with institutions to help spread these skills to students and professionals in the health sciences

Why are our courses important?

- 1. Medical practice evolves with research
- 2. Literature search is the foundation of research
- 3. If the foundation is weak, the research is weak
- 4. Weak results do not contribute to evidence
- 5. Good research -a must for evidence based practice

Objectives of the courses

To understand and learn how to:

- Search literature correctly, retrieve relevant results and save time
- Narrow down search results, and also broaden them when there are too few
- Save search strategies and search results for future review and use
- Use reference managers for storing details of books, journals and more and to cite items and create reference lists with ease

What we cover in the courses

We teach literature searching in detail, including performing detailed search strategies for systematic and scoping reviews. We teach referencing from the basics till the use of a reference manager for accurate referencing

How we work with institutions

An institution needs to subscribe to work with QMed and gets the following:

- 1. Access to the online courses for ALL its employees and students
- 2. Access to the "Library of Resources" which include links to several useful resources for research and medical writing
- 3. *Live workshops during the year
- 4. Short webinar sessions for groups or individual

How does the institution partner with us?

1. Pay an annual partnership subscription fee as below: This is valid for one year

Please note – GST will be added to the fee at the applicable rate – currently 18%

2. Plan for one or more workshops:

- a. For every institution that subscribe to our courses, we include one full day workshop, to be held on a mutually convenient date.
- b. The institution can request for additional one day workshops during the year at a nominal cost of Rs 10,000/- (plus GST).
- c. For any workshop we conduct for the institution we request the travel and stay costs to be covered.
- d. Smaller institutions could plan for short sessions over Zoom after availing of one workshop.

3. **Explore and learn from Library of Resources** that we have compiled:

In – www.qmedcourses.in – we have a library of resources – "Resources for you" – which has links to sites and tutorials useful for searching and writing and for research in general. 5. Small Group Consulting sessions:

We offer consulting / mentoring sessions specially for:

- a. Detailed search strategies for systematic / scoping reviews,
- b. Any detailed help regarding searching / referencing

QMed is open to suggestions from an institution to make the partnership very productive

Recommendations for ensuring institution wide learning

An institution should ideally plan for following to ensure that maximum numbers learn from our courses in order to ensure that every student / faculty / employee learns the skills we teach.

- 1. Appoint a team of three faculty to coordinate with QMed
- 2. Request for one-to-two volunteers from every department and UG batch, to coordinate with the main team
- 3. Spread the awareness of our courses and offerings to all students and faculty through the coordinators to ensure that people enrol (we provide a simple form to be filled by each to ensure accuracy of data and we enrol them to the courses)
- 4. Do everything possible to ensure completion of courses maybe offer recognitions / small rewards for completion
- 5. Ensure that students definitely complete the two free courses (takes only two hours). Encourage all students and faculty to complete the modules with "badges" and recommend that they try and complete certification too

How we make things easy

- 1. Our online courses can be done on any device
- 2. Every recorded video is short average duration of 5 minutes. Every video later becomes a revision tool if one forgets something
- 3. The total duration of video viewing is about eight hours
- 4. We have provided a time table that people can follow they spend 15 minutes a day and can finish the courses in 30-40 days. They can do the courses at any time within a year, and repeat the learning any number of times
- 5. Cost effective for institutions to implement and ensure skill building in this important aspect
- **6.** Every course has "badges" for important modules. And participants get certificates for every course completing a course. If an institution provides its logo for incorporation in the certificates, then it encourages participants to do more

About QMed

QMed has taught literature searching and reference management since 2008 April – via lectures and workshops. In 2018 we started our first online (Elearning) courses and since 2020 we have had them on our own platform.

Before the onset of the pandemic – we had conducted 250 workshops and we delivered around 540 lectures. During the pandemic all our teaching went online – via our ELearning courses and webinars

From April 2022 – we offer a "package" of learning opportunities via www.qmedcourses.in - online and offline courses, mentoring and the library of resources
